



## Thiessow Campsite – Rules & Regulations

Dear Camping Guest,

welcome to the campsite Thiessow, we hope you have a relaxing stay. In the interest of all campers, you should follow a few rules:

1. The Thiessow campsite is a facility maintained in the public interest, for the use of which a private fee is charged. This fee schedule is an appendix and part of the site regulations.
2. Campers and their visitors must check in at reception before using the pitch and the associated facilities and check out on the day of departure. The pitch must be vacated by 10:00 a.m. on the day of departure. Guests pay the applicable camping fee according to the fee schedule posted on the notice board. Use of the assigned pitch is mandatory.
3. It is prohibited to enclose pitches with ditches, etc. One must be careful to ensure that no one is endangered or inconvenienced by tent pegs, tent ropes, or other tent accessories. Vehicles of any kind are permitted to enter the campsite only on designated paths. Walking speed must be retained. Otherwise, the German Road Traffic Act (StVO) applies. Caravans, motorhomes, and tents may only be set up in designated pitches. Only one caravan, folding trailer, motorhome, or tent and the associated car may be parked on a pitch. **Additional vehicles are subject to a fee, and the parking area must be kept clear for arrival and departure.**
4. Quiet hours are enforced between 1:00 p.m. and 3:00 p.m. and between 11:00 p.m. and 7:00 a.m. Motor vehicles are prohibited on the campsite during these hours, and the electronic gate remains closed. Disturbing noise is strictly prohibited on the campsite. Particular consideration must be shown during quiet hours. Televisions, radios, laptops, musical instruments, etc., must be turned off during these hours so that they are no longer audible outside of your own pitch. Conversations must also be kept at a reasonable volume.
5. Order and cleanliness are standard for all guests. Your own pitch, like all other facilities and amenities, especially the sanitary facilities, must be kept clean and treated with care. Garbage must be carefully separated and placed only in the appropriate waste containers. Wastewater and feces must be emptied exclusively into the designated drains.  
The disposal of bulky waste is not permitted.

6. Drinking water should be used sparingly. Taps must be turned off after use. Misuse of water, such as water fights or vehicle washing, is prohibited.

7. Dogs and other pets must always be kept on a leash. Any soiling of the site must be avoided and cleaned up immediately. Please use the dog toilets and dog showers. Your pet must not disturb other guests.

8. Barbecues are only permitted on your own pitch or at the barbecue area. Open fires are prohibited throughout the campsite. Barbecues with charcoal are prohibited during forest fire levels 3, 4, and 5. (Please check the current forest fire level in advance at <https://www.wald-mv.de/waldprojekte/waldbrandschutz>.)

9. Use of the playground is at your own risk. Parents are responsible for supervision.

10. Campers who use the campsite without registration will be prosecuted.

11. The instructions of the campsite management and its staff, as well as the security personnel, must be followed. The campsite management reserves the right to refuse admission or expel any person from the campsite if this is deemed necessary to maintain peace and order on the campsite and in the interest of the camping guests. If a person is immediately expelled due to serious violations of the campsite rules, the fees accrued up to that point must be paid.

12. The campsite assumes no liability for lost or damaged property belonging to site users, nor for injuries or accidents. The campsite assumes no liability for damage to vehicles caused by the condition of the roads or paths or by forest cover.

13. The campsite administration is available to any guest with any requests or complaints.

14. By entering the campsite, each user accepts these campsite rules in all their aspects.

15. The current regulations governing the collection of the tourist tax are available for public inspection at the campsite administration during business hours.
